City Council Minutes

March 21, 2022

On this day March 21, 2022, at 6:00 pm, Mayor Stephen Lucas called a regular City Council meeting to order with council members Cody Jorgenson, Susan Hubbard, Clara Kay, and Greg Branson. Eric Maloy was not present for the meeting. The department heads present were: Norma Hallmark, Manfred Gilow, Mike Maberry, Bucky Elkins, and Mandy Thomas.

Mayor gave the invocation.

In the Mayor's comments, he reminded the citizens that any comment made should be during time the agenda item is being discussed.

Mayor proclaimed the month of April 2022 to be Child Abuse Prevention Month in Hawkins, TX.

Greg Branson made a motion to approve the minutes for the February 22, 2022 Council Meeting and March 7, 2022 Special Session Council Meeting. Susan Hubbard seconded the motion. The motion passed unanimously.

Susan Hubbard made a motion to table the approval of a building permit for 409 Glazner St Hawkins Tx 75765 until further information has been provided. Greg Branson seconded the motion. The Council took no further action on the item.

Greg Branson made a motion to approve the road name, Northpoint Dr., of the North Point addition. Clara Kay seconded the motion. The motion passed unanimously.

Kathy Boyd gave her resignation on March 8, 2022. Susan Hubbard made a motion to appoint Becky Attaway to the HCDC. Cody Jorgenson seconded the motion. The motion was passed unanimously.

Cody Jorgenson made a motion to approve Townsquare Interactive to handle the City's website. Clara Kay seconded the motion. The motion was passed unanimously.

The Council discussed the noise city ordinance. Chief Manfred Gilow stated that the State Law precedes the city ordinance. The Council took no action on the item.

Greg Branson made a motion to adjourn the meeting; seconded by Clara Kay. The motion passed unanimously.
