The list is to be current each week and submitted to City Hall within 24 hours of a Fire Department meeting;

Consider approval of request for the Hawkins City Council to have a current list of all Hawkins Volunteer Fire Fighters signed and dated by Fire Chief to be submitted to the City Hall within 24 hours of a Fire Department meeting and/or any time a change is made to the Volunteer roster either additions or deletions;
  - D. Consider approval of resignation of Cindy Douthitt as Municipal Judge effective January 4, 2021;
  - E. Consider approval of Ordinance No. 210111 abolishing the office of the Municipal Judge;
